## **DECISION NO. EAB-EMA-20-A008(b)**

In the matter of an appeal under section 100 of the *Environmental Management Act*, S.B.C. 2003, c. 53

## **CONSENT ORDER**

**WHEREAS** the Respondent on March 31, 2020 issued a decision refusing to amend Permit GVA0617 previously issued to the Appellant in respect of the discharge of air contaminants from a grain terminal located at 375 Low Level Road, North Vancouver, British Columbia under the authority of Section 31 of the *Environmental Management Act*, SBC 2003, c.53 and the Greater Vancouver Regional District *Air Quality Management Bylaw No. 1082*, 2008 ("**Permit**"), as amended;

**AND WHEREAS** the Appellant appealed to this Board the Respondent's decision of March 31, 2020 refusing the Appellant's application to amend the Permit to remove the air dispersion modelling requirement (the "**Decision**");

**AND WHEREAS** the Appellant and the Respondent have come to an agreement to resolve, on consent, all of the issues in the within appeal on the terms set out below;

**NOW THEREFORE** on the application of the Appellant and the Respondent this Board orders in full resolution of the within appeal and by the consent of each of the Appellant and the Respondent without a hearing, the following:

1. The Board reverses the Decision and amends Permit GVA0617, to remove the air dispersion modelling requirement set out at page 19 of Permit GVA0617.
