**CONSENT ORDER**

**WHEREAS** the Appellant, Robert Todd Lang, filed an appeal to the Environmental Appeal Board against the Respondent's decision to issue an administrative penalty against the Appellant pursuant to the *Integrated Pest Management Act* dated July 6, 2020;

**WHEREAS** the Appellant and Respondent have entered into a settlement agreement regarding all outstanding matters between them;

**WHEREAS** the Appellant admits that on May 10, 2019 he contravened s. 3(1)(a) of the *Integrated Pest Management Act*.

ON THE APPLICATION of the parties, without a hearing and by consent;

THE BOARD ORDERS under Section 16 of the *Administrative Tribunals Act*, S.B.C. 2004, c. 45 that:

1. The Appellant shall pay an administrative penalty of \$3,200 (the "Administrative Penalty").
2. The Appellant shall pay the Administrative Penalty no later than six months after the date of filing of this Consent Order.
3. The Administrative Penalty shall be paid by cheque or money order made payable to the Minister of Finance, and mailed to:

4. Each party shall bear their own costs of this appeal.
